I, BARRY ANDREWS, Minister of State at the Department of Health and Children, in exercise of the powers conferred on me by section 150 of the Adoption Act 2010 (No. 21 of 2010) and the Health and Children (Delegation of Ministerial Functions) Order 2010 (S.I. No. 508 of 2010), hereby make the following regulations:

1. These regulations may be cited as the Adoption Act 2010 (Consent to Adoption Order) (Forms) Regulations 2010.
2. These regulations come into operation on 2 November 2010.
3. Each of the forms set out in the Schedule shall be used in the case and manner indicated in the form.
